



HAABC Life Membership Guidelines

A candidate for Life Membership of the Harbour Authority Association of BC (HAABC) should demonstrate some of the following qualities. Please note that the following are guidelines only and failure to meet any one of the listed criteria should not prevent consideration for Life Membership candidacy.

- Contributed above and beyond what is normally expected of an HAABC member.
- Carried out significant service for the betterment of the HAABC Society and its goals.
- A founding member.
- Been a member for at least five years, (period doesn't have to be continuous).
- Served on the Board of Directors or subcommittee for at least 4 years.
- Life Membership shall be awarded to only one HAABC Member in any one year, (unless there are extenuating circumstances).

Such Life Membership shall be conferred at the HAABC Annual AGM/Conference banquet. Submission deadline is **January 8th, 2021** HAABC Board of Directors, upon receiving nominations for a life membership, shall appoint a committee of 3 members to document candidate credentials and report their findings back to the Board. The Life Membership vote shall then be taken by the HAABC Board.
